

Terms for Frodo PIX! Gift & Trip Giveaway

From 7/9/2025 through 7/12/2025 (the “Giveaway Period”), customers who visit participating Hot Topic retail stores and either present proof of an active Hot Topic Rewards Membership or sign up for a Hot Topic Rewards Account in-store with a Hot Topic associate will be eligible to receive one (1) exclusive Lord of the Rings™ Frodo PIX! figure (the “Gift”), while supplies last. Gifts will be available at the start of each store’s business day during the Giveaway Period and will be awarded to eligible customers on a first-come, first-served basis, while supplies last. Gifts are limited in quantity, with a limit of one (1) Gift per customer. This offer is valid only at participating retail locations and is not available online. This Giveaway is not valid for employees of Hot Topic, BoxLunch, Her Universe, or Thrilljoy, or for their immediate family members.

One (1) randomly selected Gift will be a unique 1-of-1 Chase Variant (“Chase Variant”). The customer who receives the Chase Variant and meets all eligibility requirements will be deemed the potential winner (the “Winner”) of a Lord of the Rings-themed trip for two (2) to New Zealand (the “Trip”), provided by Thrilljoy, LLC (“Thrilljoy”). To be eligible to receive the Trip, the Winner must be at least eighteen (18) years of age at the time the prize is awarded. If the Winner is under twenty-one (21) years of age, the guest accompanying the Winner must be at least twenty-one (21) years of age in order to check into hotel accommodations.

The Trip will consist solely of the following elements: (i) round-trip airfare for two (2) to New Zealand from a major airport selected at Thrilljoy’s sole discretion, (ii) hotel accommodations for a duration determined by Thrilljoy, (iii) a guided tour of Hobbiton™ in New Zealand, (iv) a VIP Tour for two of WETA Workshop in Wellington, New Zealand, and (v) roundtrip ground transportation between the airport, Hobbiton, and WETA Workshop.
