discretion) to a major commercial airport near the Experience (as determined by Sponsor in its sole discretion) (ARV approximately \$1,000 USD / \$1,404.45 CAD),

- Two (2) nights standard hotel accommodation (one (1) room, double occupancy room and tax covered only) at a hotel in Los Angeles, California (at Sponsor's sole discretion) (ARV approximately \$1,100 USD / \$1,544.89 CAD), and
- One (1) \$500 USD Visa gift card (ARV \$500 USD / \$702.22 CAD).

NO CLASS ACTIONS.
